I. **CALLED TO ORDER**

Mike Kaplan, Chair, called the meeting to order at 4:02 p.m.

II. **APPROVAL OF THE MINUTES**

The following meeting minutes were approved:

- a) May 12<sup>th</sup> special called meeting: motion by Mr. Spangler, seconded by Mr. Hazzard, approved unanimously.
- b) May 26<sup>th</sup> regular board meeting: motion by Mr. Spangler, seconded by Mr. Hazzard, approved unanimously.
- c) June 14<sup>th</sup> regular board meeting: motion by Mr. Hazzard, seconded by Mr. Spangler, approved unanimously.
- d) June 24<sup>th</sup> special called meeting: motion by Mr. Hazzard, seconded by Mr. Spangler, approved unanimously.

III. **NEW BUSINESS**

- a) Mr. Hazzard called for a special election, in conjunction with the November 6<sup>th</sup> general election, to fill the district 2 seat of the Macon Water Authority, with qualifying taking place August 1<sup>st</sup>-3<sup>rd</sup>. Mr. Spangler seconded, and the vote passed unanimously.
- b) Mr. Hazzard called for an audit of the Secretary of State's race in the May 24<sup>th</sup> primary, for the following precincts: Hazzard 4, Howard 1, and Warrior 1. Mr. Spangler seconded. Mr. Kaplan voted in favor; Mr. Maynard voted against. The vote passed by majority.
- c) As the Boys and Girls Club building is owned by the Board of Education, the club's request for an air conditioning and heating system will be passed along to the Board of Education.
- d) Due to the working conditions at the former Macy's, another storage location will be sought for the election equipment.
