NOTICE OF THE GENERAL PRIMARY RUNOFF AND NON-PARTISAN GENERAL RUNOFF

Notice is hereby given that a General Primary runoff and Non-Partisan General runoff election will be held in Macon-Bibb County, Georgia, on Tuesday, June 18, 2024, for the following official races:

Non-Partisan Offices:

County Commissioner District 3
County Commissioner District 8

State Office:

State House of Representatives – District 145 (*Democratic*)

Federal Office:

United States House of Representatives – District 2 (*Republican*)

Voters who were registered and eligible to vote in the initial election are eligible to vote in the runoff election whether that voter actually voted in the initial election.

Note: Voters registered through May 20th, 2024 will be eligible to vote for the Federal Office only in the June 18th runoff election.

Early advance voting will be held June 10th – June 14th from 8:30 a.m. to 5:30 p.m. at these locations:

- Macon-Bibb County Board of Elections main office located at 3661 Eisenhower Parkway, Suite MB101, Macon, GA 31206 (Macon Mall – Entrance on Military Recruitment side)
- Elaine Lucas Senior Center at 132 Willie Smokie Glover Drive, Macon, GA 31201 (Carolyn Crayton Park, formerly Central City Park)

Voting will be held on Election Day, June 18th from 7:00 a.m. until 7:00 p.m. for voters registered and eligible to vote in the above races.
