EFFECT OF FAILURE TO ANSWER CALENDAR

The failure to appear at a calendar sounding or otherwise to advise the Court as to whether a case is ready for trial may result in the dismissal without prejudice of plaintiff's action or defendant's answer, counterclaim, or cross claim. See U.S.C.R. 20(A); but note the following exceptions to the requirement to attend:

If less than eighteen (18) months have lapsed since the filing of the complaint then the case may be **continued by agreement between all parties** without motion. Such announcements may be submitted directly to the judge's chamber by **EMAIL ONLY TO BOTH HMorton@maconbibb.us and BCates@maconbibb.us**, by the Deadline for Announcements shown above.

Cases older than eighteen (18) months can be continued only by a motion granted by the Court. A motion for continuance may be made to the Court by filing the motion with the Clerk of Superior Court and providing the Court with a copy and proposed order. *No faxed motions will be accepted, only EMAIL. The copy of the motion and order must be received in chambers by the Deadline for Announcements shown above.*

If the parties submit timely notice of a request for continuance by agreement or if the Court grants a joint motion for continuance, counsel are excused from attending calendar call. **Personal appearance by counsel is required for all other announcements.**

You may EMAIL HMorton@maconbibb.us to check the status of your case. ***Please DO NOT CALL to check the status of your case.***

PRETRIAL CONFERENCES.

All cases announced and marked as "READY" for trial must have a pretrial conference before trial. The time of the pretrial conference is indicated above. Parties scheduled to attend a pretrial conference must bring a joint proposed pretrial order. See U.S.C.R. 7.2, 44.8.

Please be advised that if a case in which you were listed as one of the parties or as an attorney of record for one of the parties, is marked "Ready" at the July 23rd calendar call, it will be tried during the week of August 5, 2024.

- **Pre-trial Conferences will be held at 9:00 a.m. on Monday, July 29, 2024. If your case has been marked ready, you will need to attend these conferences.**

- These cases are listed in the order in which they will be called for trial during the week of August 5, 2024. **The final call of the calendar and jury selection will take place on Monday, August 5, 2024 at 9:00 AM at the Bibb County Courthouse, located at 601 Mulberry Street, Macon, GA 31201. All parties must appear at that time for their individual trials.**
- **The complete text of all Requests to Charge for those cases scheduled to be tried during the week of August 5th must be submitted in MS Word format by 12:00 Noon on August 1, 2024. These charges must be emailed to my staff attorney, Hailey Morton, at hmorton@maconbibb.us. Charges not received by the foregoing deadlines may not be given by the Court. Where a pattern charge is requested, please include the number for that charge and the text of that charge.**

It is likely that some of these cases will come off the calendar and as a result, your case may be moved to an earlier position. Unless otherwise indicated by the Court, **all** cases marked as ready are subject to be called and should be ready to proceed to trial.
